

#### Review of Role and Responsibilities of the Board:

#### Social Media:

#### CCDC:

The following is a synopsis of the status of the documents the CCDC committee is working on. The status ranges from finalization, mid development, as well as commencement of several more, as follows:

- CCDC 4 Unit Price Contract. Endorsed by CSC. · CCDC 18 Civil Works Contract. Endorsed by CSC.
- · CCDC 20 Contract Administration Guide. Endorsed by CSC.
- CCDC 16 A Guide to Changes in the Contract. This revised document was reviewed by CSC and the changes by RAIC did not affect our decision regarding endorsement.
- · CCDC 2Ma Master Agreement between Owner and Contractor. Endorsed by CSC.
- CCDC 2CcQ Contrat à Forfait. Has been reviewed on behalf of CSC and comments were sent back to CCDC for review and a response. At the time of writing this report, there has been no response from CCDC.
- CCDC 30 Integrated Project Delivery the working group has completed their review of the contract revisions and slated to have a final review in August and Peer Review in November
