ENGINEERING UPDATE

I would like to express my gratitude to Patricia on the excellent work she's completed as the former engineering officer with the CSC Toronto Chapter, a very successful student design challenge competition, and maintaining effective communication with the Ontario Society of Professional Engineers (OSPE) and fostering a new relationship with Ontario Association of Certified Engineering Technicians and Technologists (OACETT).

As I assume the role of engineering officer, my objective will be to continue the work that has been done during Patricia's term and continue the mission of educating the engineering and technology community that specifications are more than just a project construction manual. We recently participated at the OSPE Engineering Conference in November 2023, to raise more awareness about CSC. In the engaging discussions at the event our executive team provided advice to industry professionals and students on specification writing, documentation, and CSC courses. It was surprising to find that many participants, particularly those not directly involved in the building space, had limited understanding of specifications. But it led us to believe that we need to do a better job at building the recognition that specifications are a key part of the projects they're working on and will be working on. That will be my objective as engineering officer, to help cultivate the engineering and technology community to better understand Construction Specifications and build more interest in joining the CSC Association. For all engineers and technicians needing continuing education, please consider the CSC courses or the engineering societies such as OSPE and OACETT have continuing education courses/workshops that you can consider.

In addition, the engineering officer extends to support a collaborative role in the Student Design Competition, a joint imitative between CSC Toronto Chapter and CSC Grand Valley Chapter. We're reaching out to the many universities and colleges in Ontario to encourage their participation in the CSC Student Design Competition, urging them to incorporate it into their curriculum, and presenting the challenge to their architectural and interior design students. The competition will run until April 29th, 2024, with the award ceremony in September 2024 at the CSC Grand Valley Chapters connection café, get ready for some exciting results! If you're interested in learning more about the Student Design Challenge check out our website, our partners on this project are Planitar who's created the iGuide platform for a virtual 3D tour, and HIP Developments.

GOOD NEWS RELATED TO ISSUING OF OAA LIMITED LICENCES

Following my January 2024 Report, I can inform you that a group of former Licensed Technologists OAA and OAA Technology Program participants were invited to attend a virtual information session earlier in the month of February that was hosted by OAA President, Settimo Vilardi and Executive Director Kristi Doyle. The intent and purpose of the information session was to discuss the strategy in preparing for the Standing Committee on Justice Policy public hearings that were held on February 21 and 22, to



discuss Bill 157, Enhancing Access to Justice Act, 2023. If passed, this omnibus bill's Schedule 1, would achieve the regulatory foundation for the OAA to, once again, issue Limited Licenses and reinstate the OAA Technology Program. It was stressed that this would be a critical step forward in the efforts toward getting licenses reinstated to those who formerly held status with the OAA as a Licensed Technologist OAA.

The OAA did receive confirmation that they would be able to appear in person before the Committee. The goal of the OAA was to speak to their support of Schedule 1 and the ensuing that the changes to the Architects Act and, subsequently, a change to Regulation 27 of the Act.

On February 28, OAA's Executive Director, Kristi Doyle sent out an email informing former Licensed Techologists that Bill 157, Schedule 1 was passed, and this is an important step as Schedule 1 contains the necessary amendments to the Architects Act that will allow the OAA to issue Limited Licenses to specific classes of individuals, namely Licensed Technologists. Following the previous week's hearings before the Standing Committee on Justice Policy, she advised former licensed technologists that the Committee approved Schedule 1 on that morning, as written, and it will proceed to third reading shortly. This is also a very important step in the process to get the OAA's Technology Program back online, and to reissue licenses.

Despite that, Kristi Doyle advised that the OAA still have much work to do as the related amendments to Regulation 27 of the Act, needs to be approved as well. Efforts on that front will continue, and she reconfirmed that those efforts remain a high priority for the OAA as they move forward with the next steps in this process.

Further to Kristi Doyle's email of February 28, she sent out a quick update regarding Schedule 1 of Bill 157, that would affect the Architects Act and the ability to establish Limited Licenses and reported that Bill 157 received third reading in the Legislature late in the afternoon of March 05, as tabled. That meant that the Bill was passed, and now awaits Royal Assent. While the timing of Royal Assent, signalling that the Bill and its Schedules are in force, is not known, the OAA anticipates that it will happen soon. She also advised that certain sections of Schedule 1 are also subject to an effective date set through proclamation by the Lieutenant Governor.

In January, it was our Celebration Dinner. As a Chapter, we took the time to show appreciation to our local CSC Life Members and Fellows. A big thank you to everyone that attended. Additionally, we had a designer panel discussion with Tara Mackenzie, Program Director at BGIS, Lori Urwin, Principle, Practice Leader at HOK and Lily Kim, Senior Design Manager at Pomerleau. Attendees gained a greater understanding of how designers work with the 3-Part Specifications - Specifiers, Project Owners, and Manufacturer Reps to design their projects. This was a very successful event with over 75 people in attendance – a chapter milestone! Also, we would like to thank Sarah Lake of Rockfon for being the moderator.

In February, we had Robert Simpson of Vantex presenting to our membership – How to Specify Industrial Louvers. Rob was able to highlight the key factors for selecting louvers, discuss coordination between architectural and mechanical disciplines, and provided guidelines for specifying and incorporating louvers into the building's exterior. This was another successful event as we had over 50 people in attendance.

In April, we had Douglas Fishburn, President of Fishburn Roofing Sciences Ltd. presenting. Douglas Fishburn is part of a working group who has been reviewing the intent of the new CSA A123.26 – Performance Requirements for Climate Resilience of Low Slope Membrane Roofing Systems. This presentation provided an overview of the framework of the standard, including the climate zone severity classes, the roof resilience indices, and Climate RCI tool. Further, it showed the application of the standard, including guidance on strategies to improve the durability of roofing systems in anticipation of increased severity of weather events. We had over 30 people in attendance for this event.

Our last dinner meeting of the season will be held on May 9th. We have Steffanie Adams, a professor at George Brown College, presenting – "Finding Their Voices: A Case Study in Architectural Archaeology". 
